Terms & Conditions

- To confirm your chosen date, a signed Terms & Conditions form, a completed booking form and the quoted deposit payment must be received within 14 days of booking request
- Bookings may not be made by or in the name of any persons under the age of eighteen years of age
- RED Mobile Bars Ltd will apply, upon your request, to obtain a drinks license from the relevant authorities
- The hirer shall be responsible in ensuring that no intoxicating liquor purchased from the bar is taken off the premises.
- We are personally licensed and operate under the terms of The Licensing Act 2003 and all relevant restrictions will be upheld by our staff. It is illegal for anyone under the age of 18 to purchase, attempt to purchase or consume alcohol at the Event. We will refuse to serve anyone at the event who is, or appears to be excessively drunk or uses threatening or abusive behaviour towards staff, customers or other guests. We will also refuse to serve anyone who purchases or attempts to purchase alcohol for someone under the age of 18 or for someone who has previously been refused alcohol by our bar staff.
- If your event will have guests around the age of 18-25 please do ask them to bring ID with them.
- No beverages, alcoholic & soft, are to be brought onto the premises that have been purchased away from the licensed premises. If the hirer is seen not to be complying with this condition they may stand to lose the deposit.
- We will need access to Electricity supply and water supply.
- Plastic glassware will be used for all beverages unless previously agreed otherwise
- Notice of cancellation by the hirer less than 45 days of the event date shall incur the forfeit of the deposit paid.
- The hirer will be responsible for the effective supervision on the premises and for the prevention of disorderly behaviour so as to ensure that no nuisance or annoyance arises to local residents.
- For all bookings we will require set up and clear away time to be discussed. We will also require vehicle access to drop off the bar and beverages no more than 15metres from site. A site visit can be arranged.
- Waste disposal is the responsibility of the hirer
